If you are one of the following, this workshop may be for you!: Speech-Language Pathologist (SLP), Occupational Therapist (OT), Physio Therapist (PT), Infant Development Program Consultant (IDP), Supported Child Development (SCD), Early Childhood Educator (ECE), daycare or preschool teacher, etc..

The Foundations for Professionals workshop, created by BCFHRC, is designed to strengthen professionals' knowledge on children's hearing/deafness and how it relates to their development. Research shows that children who are deaf or hard of hearing are at risk for social, emotional and academic difficulties. The Foundations for Professionals workshop aims to equip professionals with the knowledge and strategies to support development and learning in these areas.

Foundations for Professionals also provides an opportunity to ask questions and engage in discussion with other professionals in your community who may also have experience in working with a child who is deaf or hard of hearing. Connecting with professionals is a valuable way to gain knowledge and share ideas.

Foundations for Professionals workshop will be covering a wide range of topics relating to hearing/deafness, including:

- Types of hearing loss
- Creating optimal learning environments
- Equipment options and strategies to keep them on
- Communication strategies
- Different ways to communicate

- Experience what it might be like to be deaf or hard of hearing during classroom activities
- Experience listening through different hearing equipment
- Adapting activities and rooms to create better learning environments
