MESSAGE FROM THE PRESIDENT

Every year in our life has its stories and it is customary that we take a few moments to review them on our birthday or some other special time of the year. In our organization, we take the day of Annual General Meeting to take stock of our work and take a glimpse into the future.

I cherish the opportunity to share this glimpse with you.

Let us look at the facts. The demand on our services has increased steadily. The number of our clients has grown and we delivered significantly more service hours. The increased demand had to be satisfied with our existing resources as our government service contracts provide us with fixed amounts of money. There are no automatic upward funding adjustments to cover unexpected growth in services. It is a sign of the high professional standards and commitment of our staff that we could satisfy the increased demand without compromising the quality of our services.

The true measure of the quality of our work is in the progress of our children. Our yearly survey of clients' satisfaction tells us that our families are pleased with the work we do with them.

Through our government funding contract, our organization is entrusted to foster collaboration among other specialized agencies such as Children's Hearing and Speech Centre of BC and Deaf Children's Society serving children who are deaf and hard-of-hearing. Over the past year we have reconciled differences in our administrative systems and our sub-contracts with these agencies are working smoothly.

The opening of our Vancouver Satellite Centre took a tremendous amount of work and preparation. We are also happy to report that both our Victoria and Vancouver Satellite Centres are doing their job! Our aim was to improve the services by making them more 'local' and more readily accessible. Parents are pleased that they can travel shorter distances to visit our facilities and have access to our professional services more frequently, if needed.

It may be surprising to learn that in the North there are still some children who do not have access to the services that they need. This is due to families' lack of access to service providers in the Yukon and NWT. It is a matter of principle for our organization to provide services to such families even if they are not covered by our contract. So far we have covered the expenses of such services through private donations, but this is not sustainable in the long run. We are now looking for funding from the Territorial governments. More donors are needed.

Our research activities have also taken off! We now have two active research projects involving our staff and collaborators from UBC. These projects investigate problems that

we encounter in our work and promise to lead to improvements in our services.

We continue to be proudly family oriented and we are planning to expand the involvement of parents in our work. In the coming year, we will explore with our families how they could help us generate positive publicity by telling their stories and mobilizing public interest in donating to our cause.

In closing, I wish to thank our staff and our volunteer Directors. The continued achievements of our organization are the result of their professionalism, expertise and hard work. We owe them our gratitude.

We had a busy and successful year indeed! The coming year promises to be the same! With thanks and regards,

REPORT OF THE INDEPENDENT AUDITOR ON THE SUMMARY FINANCIAL STATEMENTS

To the Members of BC Family Hearing Resource Society:

The accompanying summary financial statements, which comprise the summary statement of financial position as at August 31, 2018, the summary statement of operations and changes in net assets and summary statement of cash flows for the year then ended, and related notes, are derived from the audited financial statements of B.C. Family Hearing Resource Society for the year ended August 31, 2018. We expressed a qualified audited opinion on those financial statements in our report dated October 19, 2018.

The summary financial statements do not contain all the disclosures required by Canadian accounting standards for not-for-profit organizations. Reading the summary financial statements, therefore, is not a substitute for reading the audited financial statements of BC Family Hearing Resource Society.

Management's Responsibility for the Summary Financial Statements

Management is responsible for the preparation of a summary of the audited financial statements in accordance with Canadian accounting standards for not-for-profit organizations.

Auditor's Responsibility

Our responsibility is to express an opinion on the summary financial statements based on our procedures, which were conducted in accordance with Canadian Auditing Standard (CAS) 810, "Engagements to Report on Summary Financial Statements."

Basis for Qualified Opinion

In common with many charitable organizations, the Society derives revenue from donations, the completeness of which is not susceptible to satisfactory audit verification. Accordingly, our verification of these revenues was limited to the amounts recorded in the records of the Society, and we were not able to determine whether any adjustments might be necessary to donations, excess of revenue over expenditures, assets and net assets.

Opinion

In our opinion, except for the effect of any adjustments that we might have determined to be necessary had we been able to satisfy ourselves concerning the completeness of the donations referred to in the preceding paragraph, the summary financial statements derived from the audited financial statements of BC Family Hearing Resource Society for the year ended August 31, 2018 are a fair summary of those financial statements in accordance with Canadian accounting standards for not-for-profit organizations.
